Due to a waiver issued by the United States Department of Agriculture, there will be no charge for all student breakfast and lunch meals for the 2021-2022 school year. There may be Ala Carte items available for a fee.

There are no recommended fee increases this school year.

Board Policy 3520 requires an annual fee report be submitted to the board for the coming year. The policy does not require board approval of student fees, just a report.
